Pursuant to Article 4, paragraph (2) of the Law on Public Procurement ("Official Gazette of the Republic of Macedonia", no. 136/07) and Article 36, paragraph (3) of the Law on Government of the Republic of Macedonia (Official Gazette of the Republic of Macedonia, nos. 59/00, 12/03, 55/05, 37/06 and 115/07), Government of the Republic of Macedonia, at its session held on 26 December 2007, adopted the following

DECISIONON DETERMINING INDICATIVE LIST OF CONTRACTING AUTHORITIES^{*}

Article 1

This Decision shall regulate the indicative list of contracting authorities.

Article 2

The List determining the entities to which the provisions of the Law on Public Procurement apply (Official Gazette of the Republic of Macedonia, nos. 34/04 and 10/05) shall cease to be valid as of the day this Decision comes in force.

Article 3

This Decision shall enter into force on the eight day following the day it is published in the Official Gazette of the Republic of Macedonia.
